Join us for our DVAM events, and wear purple on Wednesday, October 14 – Health Cares About Domestic Violence Day – to show that you're working to end domestic violence. A Woman's Place Civil Legal Representation Program – A Vital Program for Bucks County's Domestic Violence Victims

WP's Civil Legal Representation A(CLR) program provides free legal services to victims of domestic violence. AWP Managing Attorney, Lauren Bucksner, understands that victims are frequently blocked from receiving access to the powerful and lifesaving tools that the justice system has to offer, while all too often, their abusers have no problems obtaining legal representation. Bucksner and AWP's paralegal, Diane Haines, provide legal representation and advice to victims on matters such as custody, child and spousal support, divorce, and equitable distribution. AWP's CLR program provides full access to justice to low income victims who want to live free of abusers.

Amala* is a recent AWP client from Bensalem. Pledged by her family to a man through an arranged marriage, Amala spoke no English when she joined her new husband in America, where he was already an established businessman. Throughout the devastating marriage, Amala was violently beaten not only by her husband, but also by his family. Held in virtual servitude, her husband threatened to send her back to India without their two young children if she ever crossed him. When the abuse became too severe for her to bear. Amala fled with her children to AWP's shelter, and she filed for a Protection from Abuse Order.

Amala's husband devised a diabolical scheme in retaliation. He conspired with his lawyer to purport that Amala herself had hired the lawyer, and procured a fraudulent divorce agreement and fake Property Settlement Agreement in her name, which gave all martial assets to the husband. Amala's forged signature was on both documents, witnessed by a Notary Public.

As she exited the courtroom after receiving a PFA Order, Amala was served the deceptive documents. Unable to read them, she handed them to her AWP advocate who immediately took her to CLR. Bucksner and Haines filed a petition to reopen and vacate the divorce decree and invalidate the Property Settlement Agreement. Litigation was costly and required the deposition of the corrupt lawyer and the Notary Public, the hiring of a forensic handwriting expert, the assessment of complicated financial documents, and the services of an interpreter who could attend attorney/client meetings and court proceedings.

Due to the complexity of the litigation, it took two years to get to a hearing. During that time, Bucksner successfully litigated a custody agreement and obtained substantial child support for Amala. AWP staff helped Amala find housing and access other resources to begin a safe life for she and her children.

Amala's hearing was held over two days in the winter of 2015, and Bucksner tore through the husband's case. The handwriting expert testified that Amala's signatures on the divorce agreement and Property Settlement Agreement were forgeries. After Bucksner's crossexamination of the husband's lawyer, the Judge pronounced that he would report the corrupt lawyer to the PA Disciplinary Board. When the Notary Public took the stand, he could not identify Amala as the woman who had signed the divorce and Property Settlement Agreement, as the woman who came into his office had been wearing a veil.

When I met Amala, she was so terrified and alone. Two years had gone by and she was still waiting for justice. This was her real life, her children and the husband she was devoted to. When the husband's case began to fall apart, I could see a sigh of relief in her but also of disbelief and heartache.

Facing defeat, Amala's husband withdrew his objection to the divorce decree being vacated and the Property Settlement Agreement being invalidated. Furthermore, the husband was ordered to pay court expenses, as well as spousal support retroactively to the date that the counterfeit divorce complaint was filed.

Thanks to AWP's CLR program and other services, Amala is flourishing. She is conquering the English language, has custody of her children, has a job she enjoys, and is reveling in a sense of freedom and safety that she has long yearned to experience. The Judge in the case was so impressed with the quality of AWP's CLR program that he personally telephoned Bucksner and invited her to become a member of the prestigious Bucks County Inn of Courts. But Bucksner hasn't finished working on Amala's behalf – her next step is to file a divorce complaint.

Unbelievably, the continuation of AWP's indispensable CLR program was in question just a few months ago due to limitations on the part of the funder. Funding that has traditionally covered the entire \$200,000 cost of the CLR program was lost. AWP leadership and Board was faced with a serious question: Can this program survive? The answer was simple: Not only can it survive, it must. While funds have been diverted to ensure the preservation of the CLR program, we need your help to ensure that Bucks County's domestic violence victims do not lose access to all this program offers. Amala's story is not unique, but her outcome is. Without the free programs of AWP's CLR program, there is no telling where Amala and her children would be. We must maintain this program to ensure equality for victims of domestic violence, as well as the equity of the judicial system. When I first met Lauren, I never knew anything about what my husband had done to me. I was told by my husband and his family not to trust her. But Lauren was always by my side and helped me. I knew I could have trust in her. She was always calling me to make sure I was okay and to make me feel better when I was scared. She helped me be strong. – Amala
