

1. GIFTS UNDER A WILL

The following language is an example of wording that may be used to name A Woman's Place as a beneficiary of your last will and testament. You may either make a general or restricted gift to A Woman's Place. In addition such gift may be of a specific dollar amount or it may also be of a percentage of your estate.

3. CONTRACTUAL GIFTS

asset should set forth the following as the official recipient of the gift: A Woman's Place, P.O. Box 299,Doylestonw, PA 18901, or its successors-in-interest.
